PREPARATION

Protect adjacent and surrounding surfaces not intended to be cleaned when necessary.

PRE-TESTING

Always test prior to beginning full-scale cleaning operations. Testing should confirm cleaning effectiveness on each type of surface and stain designated to be removed. Testing also determines the desired dwell time and any potential for adverse reactions with adjacent materials. Allow test panels to dry thoroughly before evaluating final appearance and results.

DILUTION

20:1 - 50:1 for mopping or spraying

APPLICATION

Apply with a mop, low pressure sprayer, or pressure washer. Allow product to dwell until soil is softened, usually within five minutes. Mop & Grip is completely safe for the soft metals so exposure time is not considered critical. Recommended maximum temperatures are in the 120° - 130° Fahrenheit. Thoroughly mop up and rinse product. If freezing conditions exist, allow adequate time for surface to

thaw. If air temperatures exceed 90° Fahrenheit, flash cool the surface with water before applying product. Graf-Ex works better at an ambient temperature of 70° Fahrenheit range. Do not allow products to dry on the surface. Always rinse thoroughly while still wet.

PRECAUTIONARY MEASURES

Always wear goggles and rubber gloves when handling this product. Keep off of skin and clothing. If material comes in contact with clothing, wash before reuse. Do not get in eyes, on skin or clothing. Keep container closed when not in use. Applicators should wear rubber boots, gloves, face shields and/or goggles to avoid splash to bare skin and eyes. Dispose of empty containers according to federal, state, and local requirements. Do not dilute Mop & Grip with any product except water. Do not use for any other applications other than specified. Do not remove label. Read Material Safety Data Sheet for additional safety and health hazard information prior to use.
