Sizzle Five Drum Pack is designed as a Distributor Bulk Truckwash Product. This Five Drum Sizzle Kit has three components that are not to be sold separately. ([1]Sizzle Powder Add-Part A, [2] Sizzle Gel-Part B, [3] Sizzle Pels Powder). This kit is designed to be sold only to distributors who have blending capability. This kit makes five drums of Sizzle Concentrate.

Directions for Blending: Items Needed:

Blend tank that has been graduated to hold at least 275 gallons of liquid. (Dish or cone bottom preferred.), Mixer, Warm Water, Paddle, Fork Lift.

To make Sizzle:

- 1. Charge tank with 225 gallons of warm water.
- 2. Add Sizzle Powder Add- Part A
- 3. Using agitation mix completely.
- 4. Add Sizzle Gel Part B
- 5. Using agitation mix completely.
- 6. Final add 2 x 5 gal buckets of Sizzle Pels Powder (corrosive powder, use PPE)
- 7. Mix Completely.
- 8. Add water to 275 gallon level on tank.

Caution: Review SDS sheets for each of the three components prior to use. Wear proper PPE when handling these products. (Goggles, Gloves and Apron)

SAFETY INFORMATION

Precautionary measures: Always wear goggles and rubber gloves when handling this product. Keep off of skin and clothing. If material comes in contact with clothing, wash before reuse. It is important to wear eye protection at all times when handling this product. Do not get in eyes, on skin or clothing. Keep container closed when not in use. Do not allow product to freeze.
